## MedEdPearls: The Role of “Instructor Talk” in the Classroom

In case you missed the February 2019 MedEdPearl, it was about how you can impact student success simply by the way you speak in the classroom! **Instructor Talk** is a term coined by researchers who looked at the impact non-content related language had on student success. Non-content language is the little things we say to students during a class session that foster a positive learning environment. Just by switching up how we talk to students can impact their perceptions. For example, switching from, “I have extended the deadline for the project” to “I have extended the deadline for the project **to give you additional time**” or from “We will begin today discussing . . .” to “**To get you prepared**, we will begin today discussing . . .” can help.

Specifically, instructor talk can:

**Promote student-centered learning** by breaking down student resistance to learner-centered environments

**Break down stereotype threat** by incorporating verbal cues that promote safety and equity

**Increase instructor immediacy** by decreasing the emotional and social gap between students and faculty

## eMedley Update

### Switching Terms

The new 2019-2020 term was created in eMedley on March 21, 2019. This is a static copy meaning that changes you make to sessions, outcomes, tagging, etc in the 2018-2019 term will not be reflected in the 2019-2020 term unless you add them/make them there as well. As such, going forward, if you make any changes to outcomes, curriculum tagging (eCurriculum), or exam item tagging (examn), you will have to make the changes in both terms (2018-2019 and 2019-2020). Modifications to exam items (e.g. changing the question text, changing distractors, etc.) should not be an issue and should reflect in both terms, if made in the 2018-2019 term only.

To check data between terms or switch terms, you would do the following:

1. After logging in to eMedley look in the upper right corner where your name is located. Just above your name will be the term.
2. If you want to change the term, click on the arrow beside your name to open a menu.
3. From this menu select *Switch Terms*.
4. This will open a window with a drop down menu of terms.
5. Select the one you want and you will be taken into that term.
6. You can double check this by looking at the term listed above your name.
