a) Institutional Policy GA-23: Emergency and Adverse Weather (revised)

Jeffrey Shawver, Vice President for Legal & Governmental Affairs and General Counsel, presented to the Committee Institutional Policy GA-23: Emergency and Adverse Weather as revised. Mr. Shawver stated that the policy revisions were needed as the policy had not been updated since 2005. Revisions included the addition of scenarios in which employees or students would be off-campus for the day, a change to the methods of campus closure alerts, and retitling the policy to "Institutional Policy GA-23: Emergencies and Adverse Weather – Class Cancellations & Campus Closures". The policy before the Committee was

circulated for the required 30-day comment period. Comments were received and addressed in the Administrative Opinion Summary attached to the revised policy.

It was moved by Marly Dunbar, and seconded by Dr. Smith, to approve the revised and retitled Institutional Policy GA-23: Emergencies and Adverse Weather – Class Cancellations & Campus Closures and to present the revised policy to the Board of Governors for approval.
